• Authorize Hiring Process for Staffing Vacancy: Reviewed the hiring process information for the current staffing vacancy. If approved by the board to proceed, the plan is for the Personnel Committee to meet this month to setup a timeline for the hiring process with the intent to make a hiring recommendation to the board in January or February 2025. Motion was made by Augustin and seconded by Eckstein to authorize Personnel Committee to proceed with the hiring process to fill one Conservation Technician position with a level 1 or level 2 job description and make a hiring recommendation to the Board for approval at a future board meeting.
